

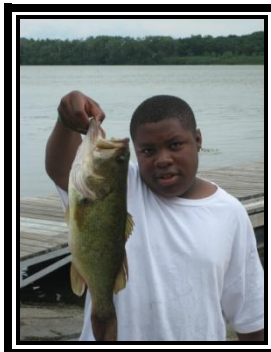

Wingra Canoe & Sailing Center Rules

Our #1 Concern is for your safety!

Please help us keep you and everyone safe by reading and following the rules!

Rules: The Rules of Wingra Canoe & Sailing Center, Inc. are designed to keep boaters and the equipment safe. Rules are subject to change and the latest rules will be posted at Wingra Boats and additional copies are available upon request. As part of the rental agreement, all participants agree to:

- Act within the limits of their boating and swimming capabilities.
- Heed all warnings and obey all staff requests.
- Maintain control of themselves and Wingra equipment they may be using
- Respect all other boaters and Refrain from acting in any manner that may cause or contribute to injuries to self or others.
- Comply with all Federal, State and local laws pertaining to the operation of watercraft.
- Check in with the on-site staff member before using any of the club equipment.
- Always have a PFD for every person in the boat and children under 16 must wear a PFD when on the water.
- Assess any equipment for damage and for suitability before taking it out, and report any problem to a staff member.
- Return all boats in the same condition as taken. Fees will be assessed for damage to equipment resulting from abuse.
- Immediately return to the boathouse at the first sign of storms, high winds, lightning, thunder or other bad weather.
- Employees have the right to deny access to boats under questionable safety conditions, including but not limited to weather and the ability to rescue the water craft in question. Any swamped or overturned boat will be rescued if the user is not able to resolve the problem within a reasonable amount of time. There will be a charge for any rescue.
- Sailboats will only be let out when there are two staff on duty.
- Members are allowed to bring guests in their boat but are not able to take an additional boat for their guest.
- Boating is only allowed during normal business hours (9am until 1 hr before dusk) unless otherwise arranged.
- Verbal or written permission is needed for all members less than 18 years of age.
- Never leave club equipment unattended. Damage occurring while boat is unattended is considered abuse.
- Pay all fees when due. Disputes regarding fees, use of equipment or equipment damage fees shall be resolved through informal discussion between the member and the club management. If unable to agree both parties will cooperate in choosing an arbitrator and the findings of the arbitrator shall be final. If the parties cannot agree on a single arbitrator, they shall each choose an arbitrator and the two arbitrators shall choose a third arbitrator and act as a panel. If there are any arbitration costs, the parties shall share them equally.

Participants who violate one or more rules may receive verbal warning or written warning. Sever or subsequent violations shall result in the suspension of use of all equipment and/or membership without refund or reinstatement.

Wingra Canoe & Sailing Center, Inc. Participant Waiver

Wingra Boats has been operating on Lake Wingra since the 1950's. Wingra Boats is an experienced provider of boating and recreation and it is our highest goal to assuring the safety of every participant. Each participant is provided a coastguard approved personal floatation device and we seek to make the experience safe as well as fun. There are, however, still risks to this activity.

This agreement is entered into between the undersigned participant and/or parent and Wingra Canoe & Sailing Center, Inc., a Wisconsin corporation with its registered office located at 2702 Monroe Street, Lower Level, Madison, Wisconsin 53711-5896 ("Wingra"). Wingra is in the business of renting boats and conducting boating events and operations on Lake Wingra in Madison WI.

Rules: The UNDERSIGNED person(s) agree to obey all rules of the Wingra Canoe & Sailing Center, Inc. The Rules are designed to keep boaters and the equipment safe. Participants who violate written or verbal rules shall be warned and subsequent violations shall result in the suspension of use without refund or reinstatement. All rules are subject to change and the latest rules will be posted at premise of Wingra Canoe & Sailing Center, Inc. It is my responsibility to know or ask for clarification of rules.

Full and Complete Release of All Liability: I, the undersigned participant and/or parent/legal guardian, being of lawful age, understand that, as in all sporting activities and particularly in water sports, there are hazards which pose risks of injury to participants. These risks include but are not limited to accidental drowning, injury caused by contact with hard or sharp objects, hypothermia, infection from water born substances, injury from collisions, or injuries resulting from broken or damaged equipment. I understand the nature of boating activities and potential injuries described above in relationship to my, or my child's experience and capabilities. I believe I or my child to have sufficient swimming and physical abilities necessary to participate in water sport activities and all other related activities.

I hereby release, discharge, covenant not to sue, and AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS Wingra Canoe & Sailing Center, Inc., their administrators, directors, agents, officers, members, councilors, volunteers, employees, other participants, sponsors, advertisers, and, if applicable, owners and lessors of premises on which the activity takes place, (each considered one of the "releasees" herein) from all liability, claims, demands, losses, or damages on the minor's account caused or alleged to be caused in whole or part by the operations, including negligent rescue operations. I further agree that if, despite this release, I, the minor, or anyone on the minor's behalf makes a claim against any of the above Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS each of the Releasees from any litigation expenses, attorney fees, loss liability, damage, or cost any may incur as the result of any such claim.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and without any inducement or assurance of any nature. I intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance shall continue in full force and effect.
